Barbara Guggenheim is a partner in *Guggenheim, Asher Associates*, one of America's best-known firms of art advisers. For over twenty-five years, she's built collections for major corporations, such as Sony and Coca-Cola, and individuals, including high-profile celebrities Tom Cruise and Steven Spielberg. Barbara holds a doctorate in Art History from Columbia University and has headed two departments at Christie's. She has written commentaries on the art world for many journals, and has been the subject of numerous magazine articles, including in *Vanity Fair* and *Forbes*. She regularly appears on power lists and has published five books, her latest *Art World: The New Rules of the Game*. In her spare time, Barbara writes humorous short stories published in *Elle* and *Harper's Bazaar* and she's a competitive tango dancer as well. Barbara is a wonderful person and an inspirational speaker on art.

Barbara will be joined by her husband Bert Fields, one of America's most respected (and feared) lawyers. He graduated Harvard Law School Magna cum laude and was editor of the Law Review. Bert is a partner in a Los Angeles law firm, Greenberg Glusker, where he litigates and does transactional law. He's represented top performers, such as Tom Cruise and Dustin Hoffman, directors, such as James Cameron and Steven Spielberg, as well as many major movie studios and top artists in the music business such as the Beatles and Michael Jackson. He is also a prolific writer, historical novels (on the Borgias and on Napoleon and Josephine), and English histories dealing with the great mysteries of the Renaissance.
